## The data you provide us

The data we process primarily consists of the data you provide us through our subscription forms. This includes your identification data and contact data.

The mandatory nature of the collected data is indicated to you during the collection process through a message. Providing certain data is mandatory only when it is necessary for us to process your request and provide a relevant response.

If the mandatory data is not provided, we will not be able to provide you with the requested service.

We also process data that you upload on our websites and applications. We never request sensitive information (such as racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, health, sexual orientation). We advise against providing such data when using our services.

#### The usage data of our services

When you visit our website or use our services, we may also collect certain information automatically, including your IP address, the type of browser you use, the pages you visit, access dates and times, and other statistics.

#### Use of the collected data

## Security of the collected data

Catalytic is committed to implementing an appropriate security policy, which translates into logical and physical security measures specifically tailored to our operations. Various audits are conducted within our infrastructure.

- Securing data access
- Regular training for our technical teams
- Voluntary limitation of outsourcing (infrastructure, services, and development) and working with anonymized test datasets
